

VI. BID FORM

The undersigned hereby declares that the instructions and specifications have been carefully examined and that **POLICE VEHICLE UP-FITTING** will be furnished for the prices set forth in this bid. It is understood and agreed that all bids are F.O.B. DESTINATION, that all unit pricing bid shall remain in effect for at least ninety (90) days from the date of the bid opening to allow for the award of the bid and that, if chosen the successful vendor, the unit pricing bid will remain firm for THREE (3) years from date of contract with an option to extend TWO (2) additional one year periods upon mutual consent.

All quantities indicated are estimated amounts for one (1) year and may vary during the course of the contract. The estimated quantities are used for assisting in the determination of the lowest responsible bidder. It is the intent of the City to purchase the services in the quantity and frequency as listed in this bid, however, the City reserves the right to reduce or eliminate this purchase without prior notice. The City reserves the right to split and/or reject all bids to realize the greatest cost savings.

Labor Pricing: Contractors submitting a bid shall provide per vehicle pricing for up-fitting labor only with the contractor supplying all installation materials (wiring, fuses, fuse containment configurations, connectors, fasteners, etc.) required to complete full up-fit installation as part of the labor portion of the bid form. Vehicle and equipment pick-up and finished vehicle delivery shall be the responsibility of the City, unless otherwise agreed upon by City designated representative.

Materials Pricing: All listed materials at pricing indicated within the bid form shall be the price used for invoicing purposes when the vehicle is completed and ready for service. Contractor shall supply all equipment listed at unit pricing provided.


